Terry discussed House Bill 5016. It would amend Section 13 of Public Act 368 of 1925 which regulates the usage of public right of ways along roads, to require a local unit of government or MDOT to provide notice one year in advance if relocation is to be requested or required of facilities of an entity holding a license under the Michigan Telecommunications Act. If notification is not provided, then these entities would have to be reimbursed by the local unit or MDOT for relocation costs. Discussion was held. It was decided to contact Representative Kevin Cotter and Representative Gary Glenn and notify them the Road Commission is strongly opposed to House Bill 5016.

Russ commented the FEMA disaster refund of approximately \$87,000 from the flooding in 2013 has been approved. We should receive money this month.

He presented the updated spreadsheet from the December 9th Rural Task Force meeting with the approved projects.

New survey equipment has been ordered and should be delivered soon.

Ben stated his mechanics are working on an overhaul of one of the tandem dump trucks expecting to save an estimated \$8k to \$10k.

He is continuing to work on outside lighting.

Sam stated Middle Road in Hope Township will be closed Monday & Tuesday for a cross-tube replacement.

The state is cutting trees on Gordonville Road west of Castor Road. He will work with them on a preferred route to minimize road damage.

Terry stated the East Central Council Meeting was very information and well attended. He held a bridge meeting with OHM discussing Castor Road Bridge for 2017. He will also be working on Alamando over Little Salt, Castor Road over Carroll Creek, and Jefferson over Herner Drain.
