INVITATION TO BID

The **Midland County Road Commission** is seeking bids for the removal of debris from 3 locations in Midland County.

The locations are as follows:

- Curtis Road over the Tittabawassee River in Edenville Township
 Note: No equipment allowed on the western span.
- Saginaw Road over the Tittabawassee River in Village of Sanford
- Pine River Road over the Pine River in Homer Township

(Photos of all three sites are attached)

The bids shall include all labor/equipment/materials necessary to remove and dispose of all debris from the waterway and all other surfaces of each bridge (trees/logs/brush/etc., however other debris may be present), and remove it from the site to a disposal location determined by the contractor.

Please separate out and **provide a cost per each structure**, however it is the intent of MCRC to award all three sites as one contract.

All bids are due by 2:00pm Thursday June 4, 2020.

Due to Covid-19 precautions all bids shall be submitted electronically by <u>emailing</u> on your company letterhead or on the provided bid form to <u>bids@midlandroads.com</u>.

Project award and successful bidder notification is expected to take place following a special board meeting scheduled at 4:00 pm on Thursday June 4, 2020, with mobilization and work to begin week of June 8. The order of work shall be coordinated by the contractor and MCRC as to avoid activities being conducted by others.

STANDARD INSTRUCTIONS TO BIDDERS - 6/4/2020 DEBRIS REMOVAL

- <u>RECEIPT AND OPENING OF PROPOSALS</u>: Sealed bids will be accepted and time stamped upon receipt in the office of the Midland County Road Commission, located at 2334 N. Meridian Rd., Sanford, Michigan, 48657, until the indicated date on the attached Notice to Bidders.
- 2. <u>BID FORM:</u> Proposals shall be submitted on forms enclosed.
- 3. <u>SUBMISSION OF BIDS</u>:
 - (a) Bids must be submitted electronically by bid form email to bids@midlandroads.com. Bids shall be submitted on your company letterhead with a cost provided for each structure or you may use the provided bid form which must be filled out completely. All submissions must be received prior to the bid opening time indicated on the invitation to bid. It is the responsibility of the bidder to confirm receipt of the submittal prior to bid opening.
 - (b) Any proposals received after the advertised time for opening shall be declared void.
 - (c) Any bidder may withdraw his bid by written request at any time prior to the advertised time for opening.
 - (d) Telephone or faxed bids are not acceptable. Telephone or faxed amendments or withdrawals will not be accepted under any circumstances.
 - (e) Unless otherwise specified, no bid may be withdrawn for a period of thirty (30) days from date of bid opening.
 - (f) Negligence on the part of the bidder in preparing the bid confers no rights for the withdrawal of the bid after it has been opened.
 - (g) Proposals received prior to time of opening will be printed and securely kept in an envelope. No responsibility will attach to an officer or person for the premature opening of a proposal not properly addressed and identified.

4. <u>SALES AND EXCISE TAXES</u>:

The Contractor shall include and will be deemed to have included in its bid and contract price all applicable Michigan Sales and Use taxes which have been enacted into law as of the date the bid is submitted. To the extent of any conflict, this Special Provision controls over Division 1 of the 2012 MDOT Standard Specification for Construction.

5. All construction work performed within the county right-of-way will require appropriate traffic control according to the current Michigan Department of Transportation specifications.

6. <u>INSURANCE:</u>

- (a) Title VI Certification: The Midland County Road Commission assures all its programs and activities will be free from discrimination, whether those programs and activities are federally funded or not.
- (b) A Certificate of Insurance will be supplied by the bidders for contractor work naming the Midland County Road Commission, its Commissioners and its employees as additionally insured.
- 7. The Midland County Road Commission reserves the right to reject any and all proposals, to waive any irregularities in the proposals received and to accept the proposal or parts thereof deemed in their opinion, to be in the best interest of the Midland County Road Commission.
