WHEREAS, projects are funded at 75% Federal Funds, with a 25% local match, and

Miscellaneous:

Terry discussed the Wetland Bank grant of \$325,000. We are going to create approximately 30 acres of wetlands. There will be a lot of sand to be hauled and we could possibly work with local contractors.

Terry discussed the asphalt recycle demo held at our shop last week and presented a cost comparative spreadsheet. The recycle machine will cost approximately \$171,000 and is not in the budget for this year. We will need a covered building to manage stockpile and keep it out of the weather and dry. The staff will look into possible grants and get prices from other vendors.

Brenda presented the 2017 Annual Financial Report.

We have received the final amended plat of Buttonville in Geneva Township section 12. Amended plat of Lots 1-6, inclusive, Block 1, Lot 7, Block 2 and the vacated portions of Glenn Street and Alley.

Staff Reports:

Russ stated the asset management culvert inventory the engineering department has been working on will qualify for reimbursement up to \$36,189.00 including \$10,000.00 to purchase equipment.

He has submitted the annual certification maps.

He is finalizing the GIS data management report for the 2017 construction season.

Art stated we had a presentation Monday on Flexamat products. It can be used on slopes for stabilization. We will be purchasing a couple piece of materials to try out.

The culvert on 8 Mile Road between Redstone and County Line has been installed.

He is working on surveys and submitting paperwork to the DEQ.

The start date for Gordonville Road and 4 ³/₄ Mile Road has been delayed due to weather.

Sam stated approximately 8 townships are able to take advantage of the extra \$12,500 in matching funds. Possible project for unused money could be Badour Road in Homer and Midland Township.

He stated the gabion baskets are scheduled to be delivered Friday.

He is continuing to work on township estimates and 5-year plans with new asphalt numbers. He has talked with Give Em A Brake Safety to give demonstration during the lunch and learn with the townships, central dispatch and fire departments.

Ben reviewed future equipment needs;

Two sign trucks Vacuum/Pumper Truck Motor Grader Wood Chipper and Truck Semi-Trucks

The shop has been really busy and he is working a skid steer prices.

Terry stated frost laws are still in effect. He will check again the end of the week and possibly take restrictions off from M-20 south on Monday. He gave presentation to the County Board on Tuesday and our millage renewal request will go before the finance committee next week.

Meeting was adjourned by Commissioner Atton at 10:35 a.m. until Thursday, May 3, 2018.
