A construction contract was received from the Michigan Department of Transportation regarding a project programmed with the FHWA, for implementation with the use of Federal Funds under Surface Transportation Program.

The majority of the DDIR's from last year's flood have been received from MDOT and signed. Bids will be taken for abutment walls for 7 Mile Road over Bullock Creek.

Commissioner Kloha inquired about the asphalt recycler. Ashley is starting to work on grant.

Commissioner Atton reported shoulder washout along M-30 near the curve at Curtis Road.
