Resolution to Defend, Indemnify and Hold Harmless the County Highway
Engineer for Professional Liability

WHEREAS, pursuant to MCL 224.1, et seq., the Board of County Road Commissioners of the County of Midland employs a county highway engineer.

WHEREAS, pursuant to MCL 224.10(2) and MCL 224.19(3), the county highway engineer fulfills and performs statutory obligations at the pleasure of the Board, which may include:

Preparation and review of surveys; preparation and review of plans and specifications for roads, bridges, and culverts; supervision over construction and implementation of said plans and specifications; and other engineering duties as appropriate.

NOW, THEREOFRE BE IT RESOLVED, that the Board shall defend, indemnify, and hold harmless, to the fullest extent permitted by law, the county highway engineer for and against any claims or liability arising from his or her acts or omissions as a professional engineer, and occurring within the course of his or her employment, and within the scope of his or her authority, while acting on behalf of the Board.

NOW, THEREFORE BE IT RESOLVED, that this Resolution shall not require the Board to indemnify or hold harmless the county highway engineer for and against any act or omission constituting gross negligence or an intentional tort.

Art stated we hosted the local Superintendents meeting on Tuesday, March 5<sup>th</sup> with approximately 30 people in attendance. Meeting was geared toward safety and training. The group wants to put on a program to train new employees for everyday activities. He stated AT & T is relocating phone lines for the Eastman Road scrap tire project, it could start as early as March 18<sup>th</sup>.

He stated there is a pre-con meeting this afternoon for Castor Road Bridge replacement that is scheduled to begin March 18<sup>th</sup> and Sturgeon Road Bridge replacement scheduled to begin April 1<sup>st</sup>.

There was a bid letting on March 1<sup>st</sup> for Coleman Road at School, Isabella Corp. was low bidder at 8.42% under engineer's estimate. Also, Magruder Road Bridge over Pine River and Saginaw Road bridge over Big Salt, C.A. Hall was low bidder at 9.71% under engineer's estimate.

Art stated request for proposals are due today for professional services and materials bids are due next Friday, March 15<sup>th</sup>.

He stated seasonal weight restrictions will be in effect starting Tuesday, March 12<sup>th</sup> at noon.

Russ stated Sam and Ashley attended a job fair on Monday at CMU and received a couple possible contacts for the engineering and GIS departments this summer.

He stated the open house at the Larkin Township office was held last night. There was quite a bit of discussion regarding the possible intersection improvements at Waldo and Monroe and the US10 interchange at Waldo Road.

Terry stated he talked with Roger Hauck regarding funding and possible changes to the ACT 51 formula. He presented charts from the asset management council comparing pavement conditions between the state trunklines, counties, and cities and villages. Charts show all entities have comparable road conditions and Terry feels no ACT 51 changes are necessary. He presented charts showing 40% increase in winter maintenance costs over the past two years.

He stated the Governor has discussed bridge bundling and he will be attending informational sessions next week at the CRA Conference.

Terry stated the most popular new county road sign is "Midland County Growing our Future" but he is still looking for suggestions and would like to start building the new signs during weight restrictions.

Commissioner Kloha stated what a great job our crew is doing.

Sam and Terry commented we have received thank you's in the form of a sheet cake from Meijer of Midland; the Ask Midland Group donated pizzas; Commissioner Atton delivered paczki's; and County Commissioner Jeanette Synder delivered donuts for the crews.

Laura Dawson asked if someone would be able to attend the County Drain meeting for the Larson Drain next Wednesday. Terry informed her staff would be in Lansing at a conference, but they would work with Doug Enos, Drain Commissioner.
