Staff Reports:

Ben stated training was is being conducted on the asphalt recycle machine this morning at 10:00 am.

Russ presented copies of the new county map. We had 2,500 copies printed to start. Updates can be made any time and additional copies will be printed as needed. He stated the CRA conference was very informative.

He will be interviewing a GIS technician with Ashley and Dave Pettersch, Gladwin County Manger, this afternoon.

Sam stated he is trying to reach Josh from the City of Midland regarding Wackerly Road. He is going to try and stop by his office this afternoon

He has talked with Neil Sweebe regarding the tile work off Gordonville Road. The Road Commission has supplied the tile and Neil Sweebe will install.

He stated the three new hourly employees will start on April 1st.

He discussed the poor condition of Betty Lane, Thomas Lane, and Bennett Drive in Lee Township. The spring thaw has made the roads very muddy. Residents contacted TV 5 news and started a petition. Sam has given estimates to the Lee Township and they have agreed to put gravel on the roads this summer, the drainage needs to be completed first. Sam is going to have a pre-construction season meeting with the contractors for the chip seal, asphalt, and gravel scheduling.

He commented on how well Jen Boyer from Emergency Services reported the spring flood time tables. She was very accurate with her timing and Sam was able to schedule our crew accordingly.

Terry stated he attended the bridge conference and updated the Board:

- Information on endangered mussels
- Bridge Bundling Package- no poor bridges by year 2025
- MDOT no longer an innovator in the state it is the counties. Craig stated Midland County is a leader in the GRS-IBS bridges and state wide these new bridges have saved over 6 million dollars.

He stated the CRA conference was very good.

Commissioner Atton commented about the water over the road on Eastman near Hurley. The drain will be replaced before the start of the construction project this summer.
