Terry had a meeting with the DNR to discuss plans for Turner Parkway, Burns Road extension, and Mier Road extension. He is working on getting a letter of agreement from DNR.

Terry also discussed a new park in Mills Township north off Shearer Road. A letter of support is needed from the DNR before project can move forward.

Correspondence was received from the County Road Association. A work group was established to clarify, streamline and modernize the CRA Constitution and Bylaws. A proposed version with changes highlighted was distributed to Board and will be voted on in May.

Staff Reports:

Art stated he held a pre-con meeting for Coleman Road at School projected to start April 29. Weigh restrictions will be lifted on Monday, April 22.

He stated there is a pre-con meeting today for the two Saginaw Road bridges and the Magruder Road bridge. CA Hall is the contractor.

He stated Poseyville Road construction will start April 22 if Consumers and AT & T have moved lines.

Eastman Road scrap tire project was shut down for a week due to weather.

Castor Road bridge project was backed up a week waiting on beams.

Art attended a meeting with Dow and Central Asphalt. Dow is interested in building a plastic road replacing some of the liquid asphalt with liquid plastic. Larkin Township has agreed to a pilot project.

Sam stated Ben is attending the training on operation of the new vac truck with the crew. Sam stated he is sending three employees to work zone training in May.

He and Kevin attended a meeting in Gladwin on new employee training. A session has been set for May 30th at the Gladwin County fairgrounds and we will be sending five employees. He is working with Larkin Township and Mark Rapanos for improvements to Wackerly Road west off Waldo Road. Once the agreement is in place with Mark Rapanos work can begin. He is having gravel and stonecrete stockpiled for summer construction projects.

Terry stated the federal aid projects should start in May:

Pine River/Shearer Road reconstruction

11 Mile-Odd-Porter Road reconstruction

Saginaw Road reconstruction in Sanford

Saginaw/Waldo Road reconstruction

He stated we are still waiting on contracts for three flood restoration bridge projects:

Redstone Road over Bush Creek

Meridian Road over Prairie Creek

Monroe Road over Newell Drain

We are also waiting on the contract for 13 county wide failure locations from the flood. Terry presented an informational flyer for the Eastman Road corridor widening project. He presented map showing which counties have already removed weight restrictions. He presented information on Pyrawall, a wrap-face vegetated solution for constructing reinforced-soil walls and steepened slopes, that he hopes to use on a couple projects this summer.

He presented suggestions from Midland Township for new Midland County signs.

Ashley stated she has been working on sign suggestions from Midland Township. She stated the interviews have been completed for the summer GIS intern, the start date is May 6.
