Jon presented an updated COVID-19 preparedness and response plan in response to the new Health and Human Services and MIOSHA guidelines. Restrictions have been loosened for fully vaccinated individuals.

Staff Reports:

Russ stated we are finally able to enter data electronically into MDOT folders related to the flood projects. Hopefully, we will receive reimbursement for emergency repairs.

He is also working on MDOT reimbursements for safety projects.

We have received a FOIA request for information about the Monroe-Waldo roundabout and Russ has reached out to them and is gathering information.

Jeff stated the pre-construction meeting for the Freeland-Sasse roundabout will be June 1 and construction is set to start June 7.

He has been in contact with the contractor on the Eastman Road project. He has marked out the segments of roadway for repair and work is set to begin when weather allows.

He showed pictures and gave update on the progress of the Coleman Road bridge replacement.

Ben stated the local Superintendents group held a new employee training day in Arenac County and he attended with four of our newest employees. Employees participated in a variety of training exercises. Each county conducted a different exercise and Ben conducted the chainsaw safety and training exercise for the group.

No new updates on the swap loader.

The new brush cutter should be arriving in a couple weeks.

Jon gave updates for Art stating the two new hourly employees will be starting on June 1 and the final summer help student will also be starting June 1. The current summer help students are doing a good job with the mowing.

The gravel spreads were completed last week and are being pulverized this week.

The chip seal crew is slightly behind schedule due to weather and expects to be completed June 4. Central Asphalt has completed the paving on 4 smaller road segments and will continue paving as their schedule permits. The drainage jobs are moving along very well.

Jon stated the Orr Road project started this week and is the first of our NRCS projects. NRCS is helping with inspection and a system is in place for completing the required paperwork. We are still working with NRCS on a couple other projects and waiting for the final approval on the design and for a couple permits from EGLE.

He had a final meeting with FEMA last week and things are transitioning to the State Police going forward to complete paperwork and to receive funding.

He had a meeting with a representative from FROST Controls on the cameras and temperature sensors we tried last winter. We were not happy with the camera clarity and lack of night vision. The cameras have been updated and we are going to give them another test before signing on for another winter.

Jon and Brenda attended a Finance and HR conference last week and discussed MTF and ARPA funding and attended an unfunded liability workshop this week with CRA and other counties to discuss how they are handling the ongoing liability.
