### Home Depot gift cards – mailbox claims

## **Staff Reports:**

Jeff has been working on revising bidding documents.

Russ is preparing for the Open House at the Larkin Township Hall for the Letts Road Connector project.

Ashley is finishing up mapping all the 2024 construction projects and she is also getting ready for a job fair at Central Michigan University, where she hopes to recruit some of our seasonal interns.

Travis is working on plans for culverts and ditches for drainage projects. He is also preparing the documents for the bids for special pavement markings.

Art completed an Aggregate Inspection Testing Certification Course to renew his certification through January 2029. Crews have been working on trees and cleanup after the last winter storm, as well as potholes. Weight restrictions were implemented on January 31, 2024 at 7am and have also been implemented in most of the surrounding counties due to the unusually warm weather we have been having. He reported that we have received and used 500 tons of our backup salt order and he will be ordering another 500 tons soon. Art reported for Steve that the new loader scales will be installed next week on the loaders. The mechanics are reporting that everything is going well in the shop and that there have been no significant problems with any of the equipment.

Jon reported that Donna and Steve are at Reasonable Suspicion training. Next week several of the engineering crew will be going to the Engineering Workshop in Manistee. He stated that there was a precon meeting for the bridge PM project a few weeks ago, which went well. The plan is to start work at the end of April. The precon meeting for the Saginaw Rd project is scheduled for February 13, 2024. Last week Jon attended the Edenville Township board meeting as they discussed their local road plan. There was lots of discussion between Jon, the board and the public about road conditions and repair types. Jon also shared that the Everbridge software will be going live next week. It will be implemented internally first, and then it can be expanded for use with public communication in the future. He stated that there are no updates on the Bailey Bridge project, which is not what he hoped for. MDOT had a February 2<sup>nd</sup> deadline for the right-of-way documents to be completed and it appears they will miss that deadline. That will more than likely result in a June bid letting at this point.

Commissioner Hyatt and Jeanette had questions about the M-30 bridge in Edenville, which Jon gave an update on.
