## 11 Mile Road Certification

Discussion was held regarding the abandonment of 11 Mile Road, between Curtis Road and W. The resolution to approve the abandonment was conditional upon retaining a 66' wide easement for public utilities and parcel owners. The easements were to be drafted, signed by all parcel owners, and recorded with the Midland County Register of Deeds. The required easements were not obtained, and maintenance of 11 Mile Road has continued in the subsequent years.

THEREFORE, BE IT RESOLVED, that the Board of County Road Commissioners, County of Midland, declares the October 14, 2020 abandonment of 11 Mile Road is invalid and the roadway shall be returned to certification.

Ashley has been working on data samples for the MPO. She is also working on easement maps.

Travis finished up the 4-way stop sign study in Lincoln Twp. He has been working on traffic signal inventory. Travis met with EGLE last week regarding bridge projects.

Art discussed how the first winter storm went with so many new employees and he was happy with how everyone handled it. He attended a Superintendent's Executive Board meeting on Tuesday in Lansing. Art is finishing up township road reviews with Homer Township tomorrow.

Steve is finishing up year-end inventory and budget and has been making sure everything is working well with the winter maintenance program.

afternoon at Ingersoll Township regarding the proposed non-motorized trail segment connecting the Midland Township Pathway to the Bailey Bridge at Smiths Crossing

Donna stated that she is finishing up this year's budget and preparing next year's budget as well as prepping for the audit in early 2026.

Jon discussed the MDOT winter budget meeting that was held at our office yesterday. He has a meeting with the Drain Commission today regarding upcoming drain projects in Larkin Township. The Bay Region Local Bridge Committee notified him informally that they selected the Stewart Road over Little Salt Creek Bridge for additional State funding due to the increased funding that will be provided by the new road funding package. He plans for this to be a 2027 project. Jon stated there is a Grade Inspection meeting for the 2026 bridge preventative maintenance project on December 8, 2025.
